

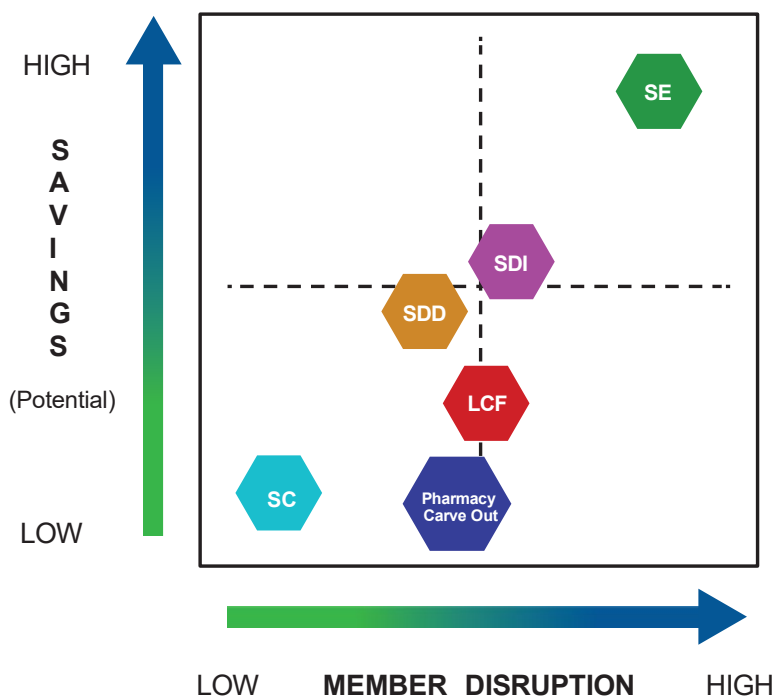

ProCare Rx SavingEDGE

SavingEDGE delivers a multi-faceted approach to secure savings on high-cost medications. This program enhances and replaces prior programs by offering ad-hoc combinations of customized and innovative solutions, such as:

- 🔍 **SMART COPAY.** A program that lowers the cost of select medications to both the Patient and the Plan Sponsor by using a variable (what we call “smart”) copay tier. This allows us to set the copay at an amount that makes better use of the Pharma Manufacturer copay assistance funding and maintains compliance with state regulatory guidance relating to accumulator tracking.

- ◉ **SMART DELIVERY.** We reduce costs for select generic and brand medications for patients by utilizing a Focused Pharmacy Network with specific third-party pharmacies that offer lower pharmacy prices.

International: A home-delivery mail order program that assists Patients in obtaining refills of select high-cost brand medications from an International Pharmacy at reduced costs. This allows Plan Sponsors to minimize Patient copays, while significantly lowering costs for the Plan. Patients will need to acknowledge and follow FDA guidelines regarding the personal use of imported medicine in order to participate.

Domestic:

- ◆ **Brand Drugs:** A refill-only home delivery program leveraging a network of pharmacies with access to regulated programs providing significant discounts on high-cost drugs to Patients meeting the program registration/enrollment requirements (including one telemedicine visit).
- ◆ **Generics:** A cost plus mail order program where the patient has access to a defined list of generic drugs at lower cost.

Traditional Mail Order: Plan sponsors may use our URAC-accredited mail order pharmacy or one of our network third-party mail order pharmacies. If a mail order pharmacy needs to be added for your Plan and Members, we will work with you to get them credentialed and contracted.

- ◉ **SMART EXCLUSIONS:** For plan sponsors creating a formulary that excludes certain drugs, we help patients find alternative financial assistance, apply for patient assistance programs, and obtain funding from charitable foundations.
